SUNWAY TES - ACCA GLOBAL AUDIT SIMULATION

Together with ACCA Malaysia and with support from the International Professional Services Firms (Big 5), the Global Audit Simulation triumphs as an exclusive opportunity for participants to translate academic learnings into practical experience through a simulated external audit. Eight years since its pioneering at Sunway TES and held bi-annually in June and December, the programme continues to be the only real-world case-based audit simulation offered at zero cost to students pursuing an ACCA qualification at our institution.

Similar to a one-week crash course in audit, this eight-day programme is designed to provide participants with an as real as possible working experience so they can acquire practical audit work skills through effective time management, teamwork, communication and leadership; be equipped with the fundamental skills, gain insights to industry demands, be exposed to audit methodology and have their presentation reviewed by one of the Big 5 firms at the end of the programme, all of which are essential to ensure work readiness.

Virtual audit sessions prepare students for real world

SUNWAY TES Centre for Accountancy Excellence (CAE) in partnership with Association of Chartered Certified Accountants (ACCA) Malaysia held the Sunway TES - ACCA Global Virtual Audit Simulation 2022.

The real-world case-based audit simulation is offered at zero cost to help students pursuing ACCA.

The eight-day programme is offered twice a year in June and December.

The aim is to help students cultivate leadership skills, build character, enhance soft skills and foster teamwork to ensure participants are able to respond dynamically to demanding audit requirements in the real world.

The December 2022 session hosted 30 teams including 40 participants from Brunei, China, India, Indonesia, Nepal, Pakistan, the Philippines, Sri Lanka, United Arab Emirates and Vietnam.

This is the most number of countries since the launch of the programme in 2015.

Sunway College executive director Prof Teo Ee Sing said they started with only 30 participants.

"In June 2022, we hosted 380 participants.

"We hope through this programme, our participants can translate classroom knowledge into practical audit work skills.

"They have to understand how to commence an audit through the development of an audit plan and determine an appropriate methodology.

"They must do all this while working together as a team," said Prof Teo.

IGNITES (Inspiring, Global Networking, Innovative Through Talent, Employability, Simulation) senior lecturer and head Kiran Seth said the programme

added value to a participant's resume.

"Sunway TES is the only institute to offer this unique programme that simulates all the elements of a real-world audit."

The highlight is the audit review process by managers from the Big Five firms which are supporting the programme - BDO, Deloitte, Ernst & Young, KPMG and PwC.

"On the final day of the programme, these managers will study the students' audit findings and give feedback.

"This is to ensure our participants are employment-ready," said Kiran.

The programme includes a one-day audit workshop by BDO Malaysia that prepares participants for the audit simulation.

The alumni of Sunway TES were also involved as clients to provide a complete real-world audit situation.

Participant Trisharnt from Malaysia, who is pursuing the final professional level of ACCA papers, shared that the Global Virtual Audit Simulation programme was very informative and insightful.

"As an ACCA student, the syllabus is purely theoretical.

"This programme provided me with hands-on audit experience," said Trisharnt.

A participant from Pakistan, Junaid Imran, said, "Auditing is my favourite subject and I always wanted to work in an audit firm.

"I am grateful to have this practical experience in auditing".

IGNITES was introduced last April by Sunway TES CAE as a comprehensive student and graduate development programme.

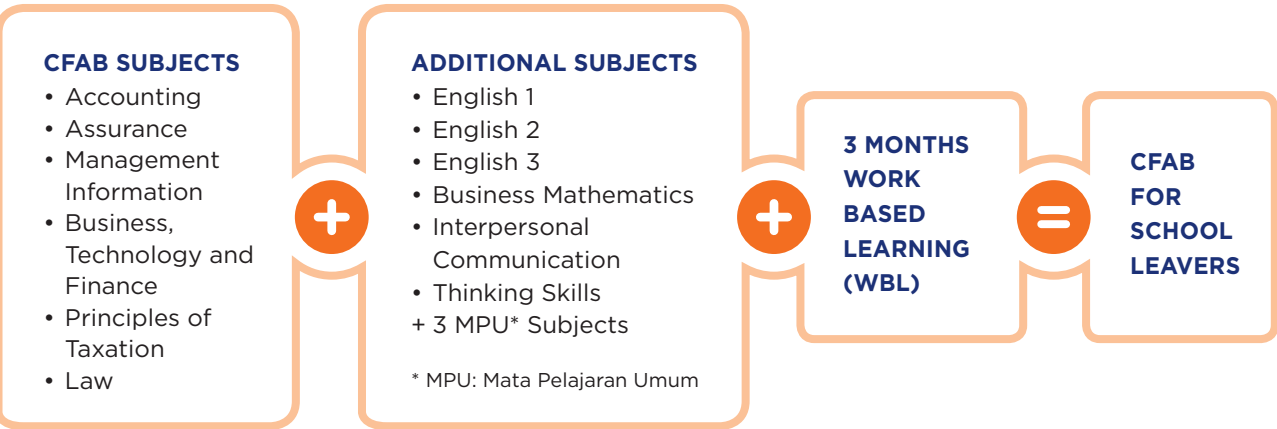

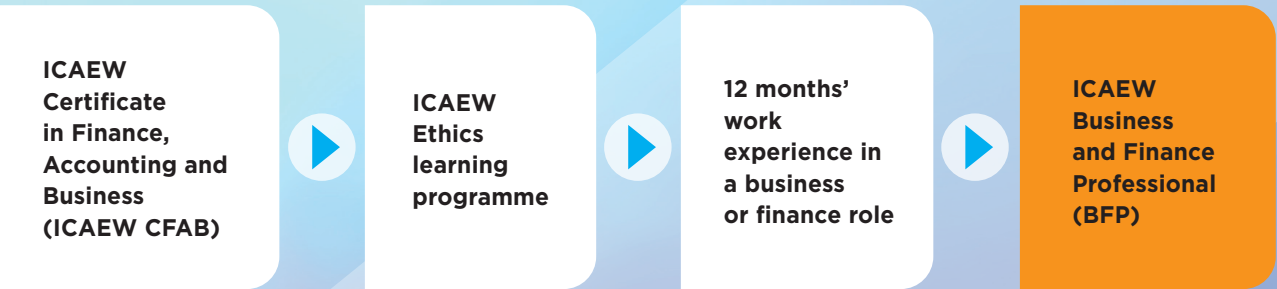

ENTRY REQUIREMENTS

Academic Requirements

Aged between 18 to 23 years, with one of the criteria below:

- Diploma / Advanced Diploma and Degree in any field of studies from a nationally accredited university (CGPA 2.50 / pass)
- CFAB (pass)
- STPM / A-Level (CGPA 3.00 (BBB) and above / BBB and above)
- AUSMAT / SAM (ATAR 80 and above)
- CIMP / CPU (80% and above)
- MUFY (80% and above)
- UEC (15 points and below in best 5 subjects (including A's in English and Mathematics, minimum of B's in the remaining 3 subjects)
- Any foundations approved by MQA (average mark of 80% and above)

For pathway iii, iv, v, vi, viii, credit in SPM Mathematics and English is required.

English Language Requirements

English language proficiency may be demonstrated by any of the following:

- Evidence that English is the language of instruction in secondary or tertiary studies completed;
- OR
- IELTS (academic) minimum 6.5 and at least 6.0 for each individual band
 - TOEFL (paper-based) minimum 600 and TWE (Test of Written English) 6

FOR NON ACCOUNTING GRADUATES

You don't need a background in accountancy or business-related subject to study for the ACA. In fact, only 18.5% of ACA students globally are from the Accounting and Accounting & Finance background. It does help if you are competent with numbers and confident in your ability to analyse, discuss, argue and present a case.

CREDIT FOR PRIOR LEARNING

If you have an accounting or business-related degree, you may apply for credit / exemption from an ICAEW exam module.

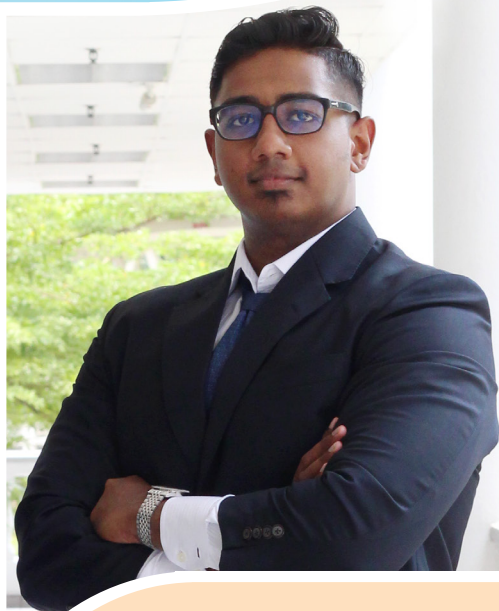

The ACA qualification combines study and exams with 'on-the-job' experience. You'll be based with an employer, doing real work and earning a salary as you train. It normally takes three to five years to complete, depending on the route you take. You'll need to find an authorised employer to support you and enter into a training agreement with them.

The training agreement will outline the support you'll receive during training and will include details about tuition, study leave and mentoring.

In addition to giving you time out of the office to study, your employers will pay for your tuition with a dedicated provider and also pay for your exam and student registration fees.

You'll need to successfully complete the ACA qualification before you can apply to become a member of ICAEW. Once this is approved, you can use the letters ACA after your name and will be recognised as an ICAEW Chartered Accountant.

HOW IS THE ACA QUALIFICATION STRUCTURED?

The ACA qualification is made up of four elements which provide students with a combination of finance knowledge, accountancy skills and real-world business experience.

- 1 450 days of practical work experience** - offering invaluable insights into the realities of a career in chartered accountancy.

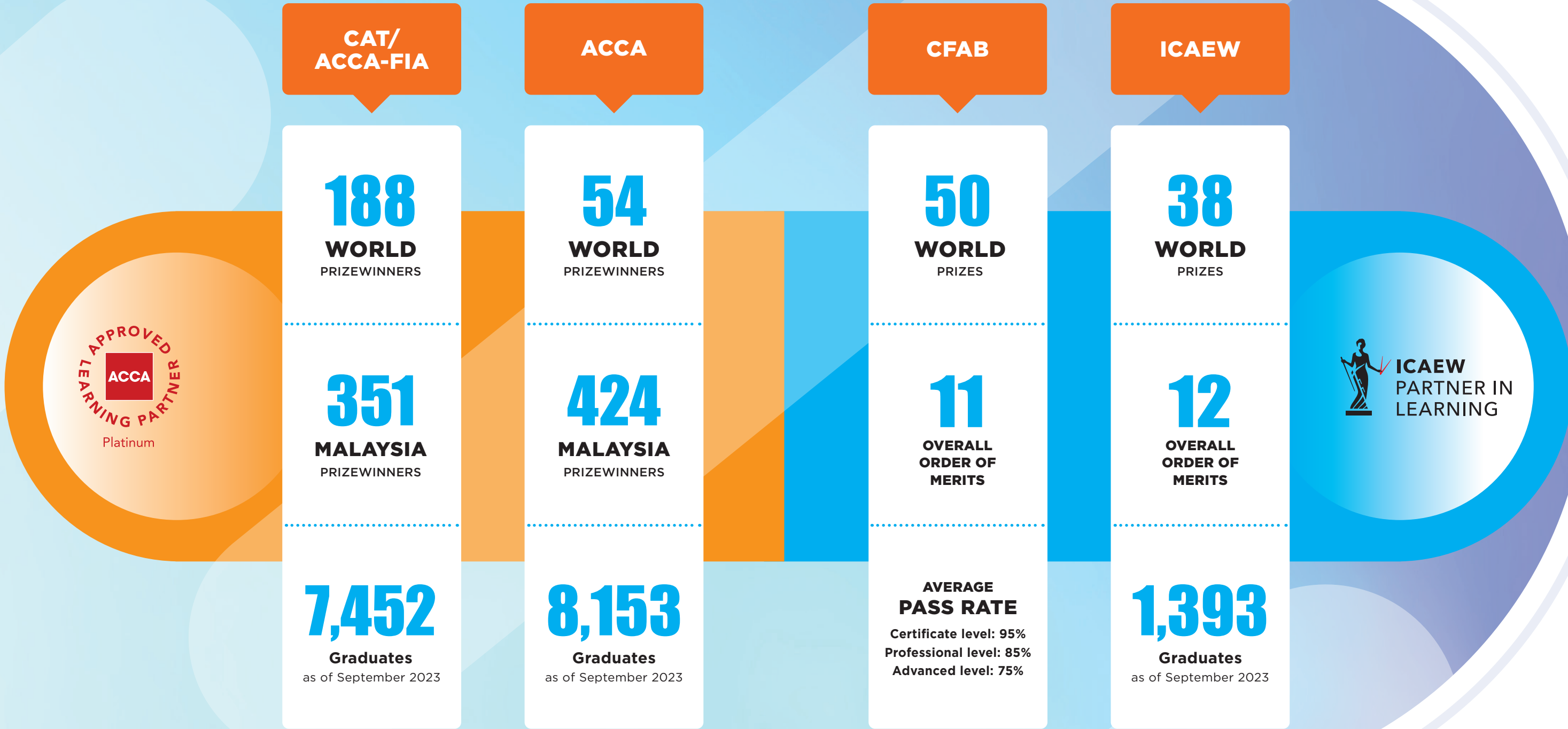

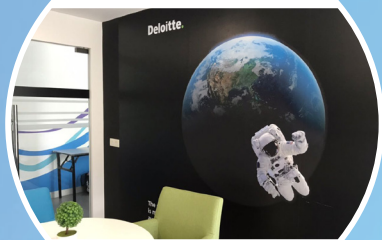
